The Duties and Responsibilities of the Parent Teachers Association are as follows:

Subject to overall control of the society/Trust, the T.I.M.E School, Bandlaguda Jagir, Association shall have the following powers/functions:

- 1. Utilisation of Funds: The amount realised through subscriptions shall be utilised for providing drinking water / sanitary facilities or for providing science apparatus Audio-Visual aids and furniture etc. However, this shall not be treated as a source of income for the institute, for providing the above facilities.
- 2. Maintenance of Accounts: The Secretary/Treasurer shall maintain accounts for the amount collected and the amounts spent for the purpose of the association. These accounts shall be audited at the time of the annual inspection of the institute by the inspecting officer's concern.
- 3. Verification of Stock and Accounts: The Articles, the equipment and aids purchased shall be entered in the stock register maintain for this purpose. The stock shall be verified at the time of annual inspection of the educational institution.
- 4. Purchase of the Aids, Articles, and Equipments: The association at its first meeting shall decide the aids, articles and equipment to be purchased. The Secretary/Treasurer of the association shall purchase them as per rules.
- 5. It is open to the association to discuss any matter relating to the improvement of the institution.
